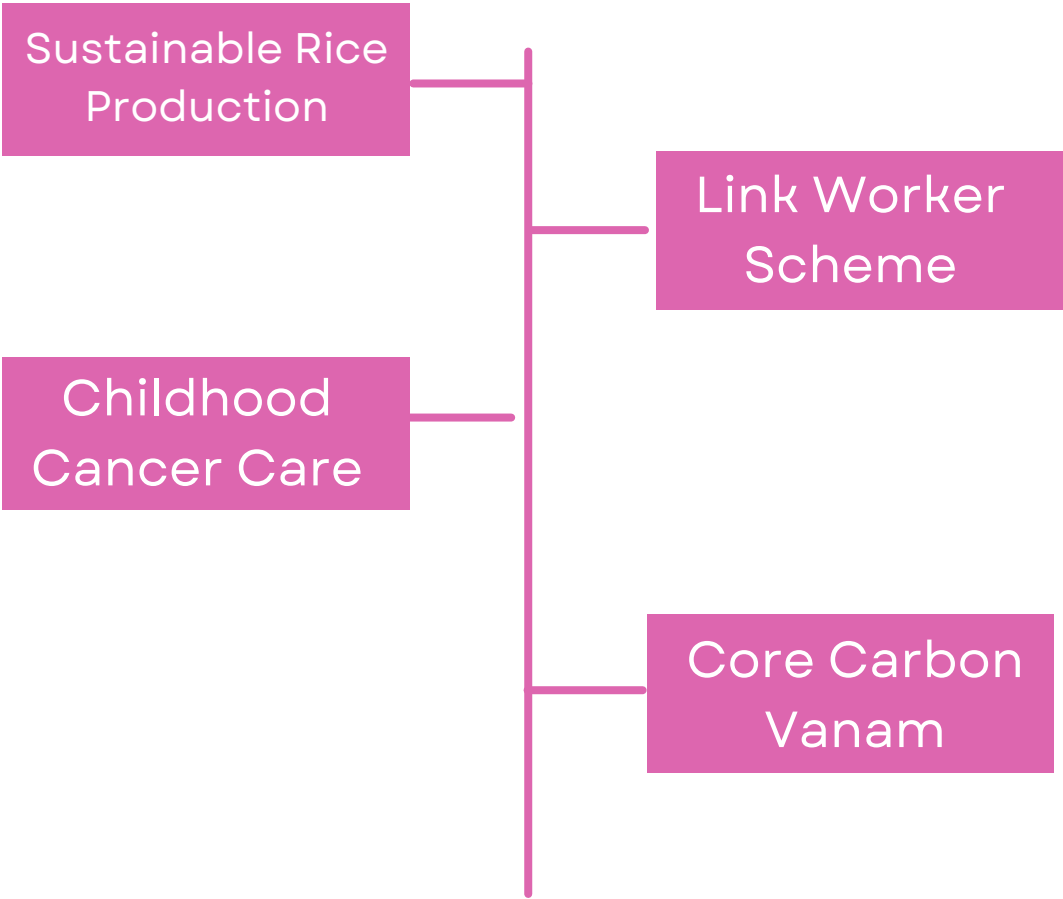

LINK WORKER SCHEME

Karimnagar Supported by NACO



Link Worker Scheme (LWS) has been designed to intensify and consolidate the prevention services, focusing on the at-risk population in rural areas.

PSHE is implementing LWS with support of Telangana State AIDS Control Society at 100 villages in Karimnagar Joint District (Peddapally, Jagithayal and Siricilla)

GOALS

- Address the complex needs of rural HIV prevention, care and support requirements in selected geographies
- Reaching out to rural population who are vulnerable and are at risk of HIV/AIDS in a non-stigmatized enabling environment
- Improving access to information materials, commodities (condoms, needles/syringes) through collaborating with nearest TI or government health facilities, testing and treatment services ensuring there is no duplication of services or resources.

SUSTAINABLE RICE PRODUCTION

with Core CarbonX Solutions Pvt Ltd

Sustainable Rice Production is implementing at Kamareddy and Karimnagar districts of Telangana State, supported by Core Carbon X Solutions since 2022.



- ✓ **Entrolling rice farmers in a program to implement AWD rice cultivation practices**
- ✓ **Decreases water consumption by up to 30% and allows for more oxygenation of soil**
- ✓ **Reducing anaerobic decomposition and methane emissions by up to 50%**
- ✓ **Methane avoidance, delivering action towards the UN Global Methane Pledge**
- ✓ **SDGs :Climate Action , No Poverty , Zero Hunger, Responsible Consumption and Production, and Partnerships for the Goals**

The Project enrolls rice farmers in a program to reduce greenhouse gas (“GHG”) emissions by improving their rice cultivation practices and rewards participants with a portion of the proceeds received through the sale of Verified Carbon Units (“VCUs”) generated.

CORE CARBON VANAM

with Core CarbonX Solutions Pvt Ltd

CCX is the Project Proponent (PP) of the “Core Carbon Vanam,” a carbon offset project. PSHE implemented the Project in 4 places in Telangana: Kamareddy, Karimnagar, Peddapalli and Jeedimetla districts.

The individual farmers are the owners of the lands on which trees are being grown to sequester carbon and reduce greenhouse gas emissions from the atmosphere.



The project encouraged and provided assistance for farmers to grow tree species ranging from fruit-bearing trees like Indian blackberry, guava, and mango to commercial species like teak, mahogany, sandal, etc, that will sequester carbon and reduce greenhouse gas emissions from the atmosphere.

1 A beacon of hope

Mravanthi (name changed), a 33-year-old female sex worker. She tested positive; she was mentally and emotionally down and started losing hope because of her condition. LWS team connected her with ART and DSRC Services, they also equipped her with essential resources such as condoms to promote safe practices

PSHE LWS team connected with Local Community and Local level leaders and took an innovative step to enhance HIV AIDS Awareness and decreasing stigma through wall painting done with support of community in public places

1 Sustainable Rice Production

" Our decision to use wet and dry paddy production was motivated by the reduction in water use. However, along with water conservation employing the technology, will also help as to reduce methane emission, not only we can part to save nature but also generate carbon credits as additional income "

2 Core Carbon Vanam

"Farming gives me a sense of satisfaction and happiness, but before I came to know about the PSHE Core Carbon Forest Project, I did not know about carbon farming. I learned that planting carbon-sequestering trees can reduce greenhouse gas emissions. Now I can be part of reducing carbon emissions through this project.
